DESCRIPTION

The Human Genome Project (HGP) and the continuing rapid progress in genetics and genomics are producing new insights and vast amounts of information that will ultimately revolutionize medicine. Increasingly, we are identifying a genetic contribution to all human disease and the prospect of genetic testing for predisposition to disease, molecular diagnosis, prognosis and response to treatment is becoming a reality. In short, genetic information about individual patients is more and more relevant for all of medicine. These developments are giving rise to a new individualized view of health and disease: "genetic medicine".

This 1-1/2 day course is designed to highlight the new discoveries in genetic medicine for use in your clinical practice TODAY.

WHO SHOULD ATTEND

This activity is intended for physicians (primary care and sub-specialists), nurses, nurse practitioners, physician assistants, genetic counselors, and physicians in training.

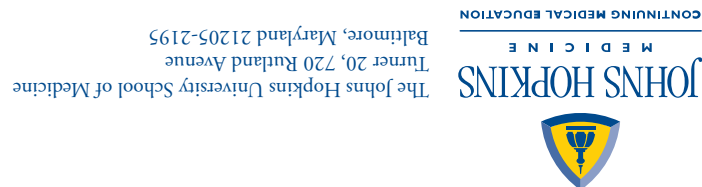
